WHEREAS, during the bid opening, the Eligibility/Technical and Financial Components of the bid of JOEBZ Computer Sales and Services as well as the Eligibility/Technical and Financial Components of the bid of the Electrocomputer Data Systems were all rated "PASS";

WHEREAS, during the bid evaluation, the bid of the JOEBZ Computer Sales and Services for the project "Procurement of Various ICT Equipment and Computer Software for CY 2021 (MITHI)" were compliant with the technical specifications and within the ABC (copy of the abstract of bids is attached hereto) hence, were declared as the lowest calculated bid (LCB) to wit:

To recommend the Award of Contract to the Head of the Procuring Entity (HOPE), DOST Regional Office No. VIII, Government Center Candahug, Palo, Leyte for the aforementioned project to JOEBZ Computer Sales and Services in the amount of Nine Hundred Sixty Seven Thousand Eight Hundred Seventy One Pesos and 5/100 (PhP 967,871.05).
