Subject: Creation of the National Competition Policy (NCP) - Focal Committee (NCP-FC) for the DOST-Office of the Secretary (DOST-OSEC)

In the interest of the service and in view of the adoption and implementation of the National Competition Policy (NCP) by virtue of the Joint Memorandum Circular No. 01, series of 2020 between the National Economic and Development Authority (NEDA) and the Philippine Competition Commission (PCC), and the Administrative Order No. 44, series of 2021, the NCP-Focal Committee (NCP-FC) of the DOST-OSEC is hereby created with the following composition:

Further, to ensure the continued compliance of the DOST-OSEC with the above-cited issuance and the requirements of the AO25 for the grant of the Performance-Based Bonus (PBB), hereunder are the functions of the NCP-FC:

1. Act as the liaison and coordination unit of the DOST-OSEC for NCP-related concerns;
2. Facilitate the Agency's compliance to the NCP requirements;
3. Coordinate with the appropriate offices/units within the DOST-OSEC to ensure the compliance with the NCP requirements;
4. Ensure the timely submission of the NCP requirements within the prescribed timeline to the PCC as the validating agency;
5. Attend NCP-related trainings/orientations provided by the validating agency;
6. Coordinate with the DOST-OSEC Performance Management and Monitoring Team (PMMT) for Performance-Based Bonus (PBB)-related compliances/submissions; and
7. Perform other related tasks assigned by the DOST Secretary.

The chairperson, vice-chairperson and members of the Committee shall serve for a period of two (2) years.

This Order shall take effect immediately and remain in force until revoked.
